

Privacy Notice: Sand App

Purpose of Sand App

The Sand App is used to analyze sand and aggregates. The obtained results include the particle size distribution and particle shape information. In long term a global sand map including analytical and GPS data of the sand origin (sand pits) will be created to improve services and concrete mix designs.

Data Capture

According to the implemented scope, the following personal data of Sika employees and customers can or will be stored and processed on Sand App:

- E-Mail addresses, date and time of a certain analyses, original and contour images, Sand pit GPS location (confirmed by user) to store the location of the analysis, analytical data and user comments.

Email address and customer name are required in order to log in in the App. Other data is required to connect to our customers and projects to improve our technical support for our customers.

The analyzed data are linked to a User (Mail-ID) to enable following functions:

- Make sure that users can access their data (Access control)
- Store the consent of the Users(user acceptance)
- Understand how the apps are used by certain users to improve the app in the future
- Troubleshooting in case the user needs support

Data Access

Access to the system is granted based on the need-to-know principle.

External: access to own and shared analyses ((without personal data)

Internal normal user: access to own and shared analyses ((without personal data)

Internal super user and support team: access to own and shared analyses, access to data lake in Power BI, access to analytical webpage for user support

Super users and support team are users who have access for following purposes: Supporting app users if they have questions, reviewing quality of performed analysis to give users feedback, analyzing how the apps are used to improve the app further in the future, operational support of the apps, review the analysis to further improve the backend processes.

We do not disclose your personal data to third parties unless you have explicitly consented to such disclosure or we are legally obliged or entitled to disclose data due to local legal requirements and/or

official governmental court orders or we have legitimate interest to do so, such in case of maintenance and support. In those case, technical security measures are in place to ensure that the data is transferred in a secure manner (e.g. encryption).

Your data are stored in the data centers located in EU.

YOUR RIGHTS:

(a) Right of access:

You may have the right to obtain from us confirmation as to whether or not personal data concerning you is processed, and, where that is the case, to request access to your personal data. This access information includes – inter alia – provision of the information about the purposes of the processing, the categories of personal data concerned, and the recipients or categories of recipients to whom the personal data have been or will be disclosed.

However, this is not an absolute right, and the interests of other individuals may restrict your right of access.

You may have the right to obtain a copy of the personal data undergoing processing.

Your requests are generally free of charge. We may charge a reasonable fee based on administrative costs in case your request is manifestly unfounded or excessive, in particular because of its repetitive character.

(b) Right to rectification:

You may have the right to obtain from us the rectification of inaccurate personal data concerning you. Depending on the purposes of the processing, you may have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

(c) Right to erasure ("right to be forgotten"):

Under certain circumstances, you may have the right to obtain from us the erasure of personal data concerning you and we may be obliged to erase such personal data.

(d) Right to restriction of processing:

Under certain circumstances, you may have the right to obtain from us restriction of processing your personal data. In this case, the respective data will be marked and may only be processed by us for certain purposes.

(e) Right to data portability:

Under certain circumstances, you may have the right to receive the personal data concerning you, which you have provided to us, in a structured, commonly used and machine-readable format and you may have the right to transmit those data to another entity without hindrance from us.

(f) Right to object:

Under certain circumstances, you may have the right to object, on grounds relating to your particular situation, to the processing of your personal data by us and we can be required to no longer process your personal data.

Moreover, if your personal data is processed for direct marketing purposes, you have the right to object at any time to the processing of personal data concerning you for such marketing, which includes profiling to the extent that it is related to such direct marketing. In this case your personal data will no longer be processed for such purposes by us.
